- ► CONCEPT-Packaging of information is a physical recording arrangement and presentation of information on a given medium and a given form. Repackaging of information refers to the presentation
- Information in more understandable, readable, acceptable and usable forms. Information repackaging is a method to pack the consolidated information within the type that is usable for library users. The aim of repackaging is to reinforce the acceptance of usage of information source and assimilation and recall of their contacts.
