I am directed to inform you that the Post Graduate Research Council (Faculty of *Commerce*). Patna University at its meeting held on 19.01.2016 considered and resolved to approve the Ph.D registration of the candidates whose applications were recommended by the Departmental Council of the respective department after following the procedure laid down in Uniform Ordinance and Regulations governing award of Ph.D Degree by the Universities of Bihar approved vide letter no. 
