 Regarding amendments in the admission ordinances for admission on Entrance Test in M.A. / M.Sc. / M.Com. courses.

It was resolved to approve the Proposed amendments in the existing (& approved) Ordinances for Admission into M.A. (under the faculty of Humanities), M.A.(under the Faculty of Social Sciences), M.Sc. (under the Faculty of Science) and M.Com.(under the Faculty of Commerce) received vide the letter no.BSU(Regulation)-55/2014-1262/Gs(I) dated 28.8.2015:-

Clauses 2.4 of the Ordinances for Admission into M.A. under the Faculties of Humanities and Social Sciences and clause 2.4 of the ordinance for Admision into M.Com. under the Faculty of Commerce be replaced by the following:-

"Admission to M.A. and M.Com. Part-I courses shall be made in order of merit on the basis of marks obtained in the entrance test."

In clause 2.11 of the ordiance for Admission into M.Sc. under the Faculty of Science including M.A. in Mathematics and Statistics, the words, "Admission of Students to the Post-graduate courses in statistics and mathematics in the Faculty of Social Sciences shall be made in order of merit on the basis of marks obtained by applicants in Statistics and Mathematics at the Bachelor examinations "be replaced by the words," Admssion of students to the Post-graduate courses in Statistics and Mathematics in the Faculty of Social Sciences shall be made in order of merit on the basis of marks obtained in the entrance test".

In clause 2.11 of the ordinace for Admission into M.Sc. under the Faculty of Science, a subclause 2.11(A) be added, which is as follows:-

"Admission to M.Sc. Part-I course shall be made in order of merit on the basis of marks obtained in the entrance test."

It was resolved that recently created Department and the Departments which will be likely to be created will have separate Bank accounts. The Head of the Department alongwith the Finance Officer and Budget & Accounts Officer will be signatories of the bank account, out of which the Head of the Department and either the Finance Officer or the Budget & Accounts Officer will be co-signatory. The Department of Women's Studies, P.U. will open its bank account as per the resolution mentioned above.
