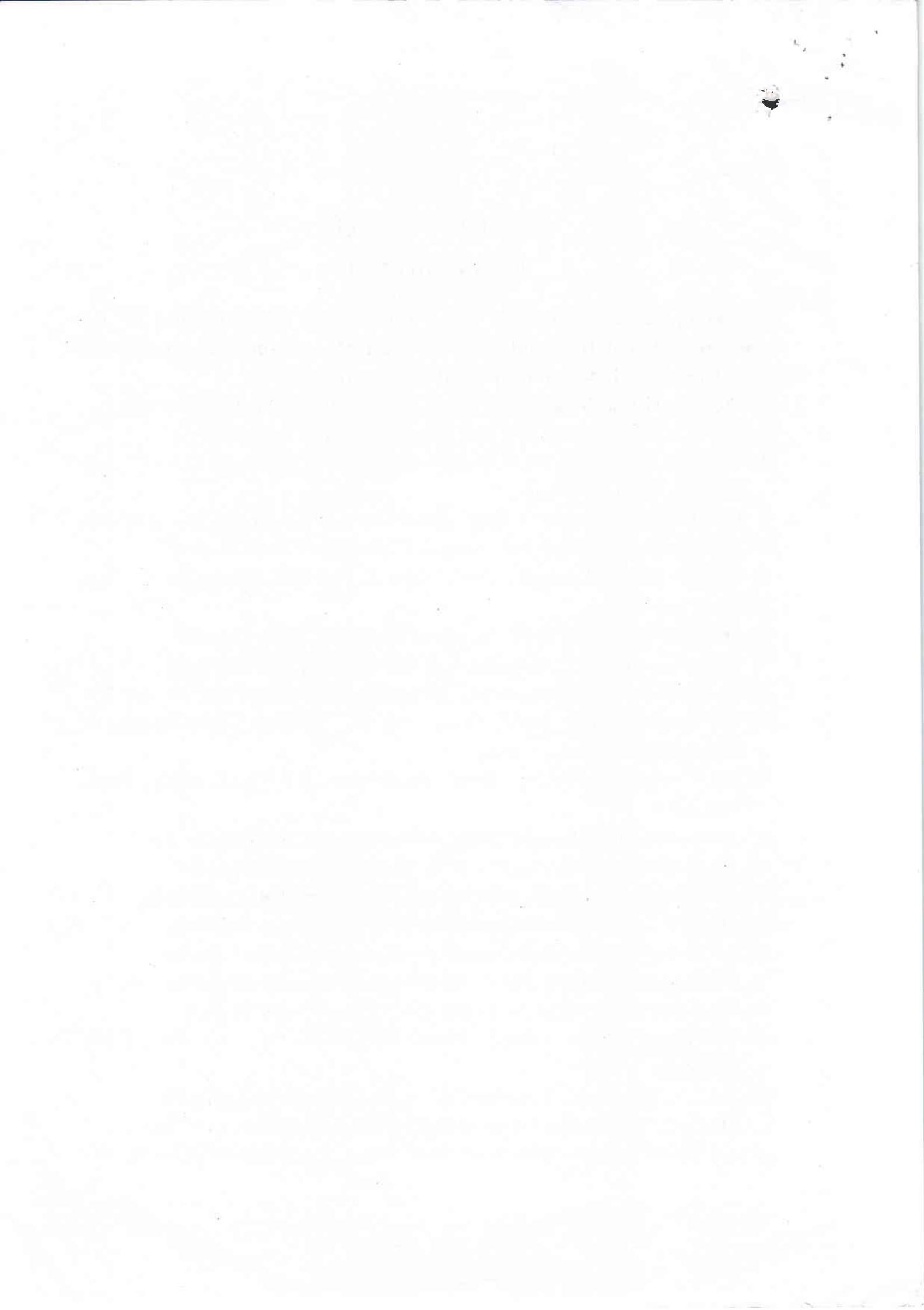


At the start of the meeting, the Vice Chancellor welcomed all the members, especially the new members and then, the business of the meeting started.
